PRIVACY STATEMENT ASAPCLOUD

PERSONAL DATA THAT MAY BE PROCESSED

ASAPCLOUD can process the following personal data:

ASAPCLOUD may process your personal data because you use the services of ASAPCLOUD and/or because you provide these data yourself by filling in a form on ASAPCLOUD's website.

- Your first and last name
- Your job title
- Your gender
- Your department
- Your address details
- Your telephone number
- Your email address
- Your IP address
- Your company name and its address details
- Information about your location, device, browser settings and browsing behavior.

WHY ASAPCLOUD NEEDS DATA

TO PERFORM THE CONTRACT THAT HAS BEEN CONCLUDED

ASAPCLOUD can use your personal data in the context of performing a contract for services concluded with you. In order to send a newsletter, for instance.

TO CONTACT YOU AFTER A CONTACT REQUEST

ASAPCLOUD processes your personal data in order to be able to contact you by telephone if you request this and/or to contact you in writing (by email and/or post) if you cannot be reached by telephone.

NEWSLETTER

We need your email address and full name in order to send you a personal newsletter. These data will only be used for the sending of the newsletter. You can unsubscribe from our newsletter at any time using the link at the bottom of every newsletter.

TO OPTIMISE, IMPROVE AND SECURE THE FUNCTIONING OF THE WEBSITE

ASAPCLOUD's website tracks general data on website visitors, including your computer IP address, the time the website was visited, and data that your browser sends. These data are used to analyze visitor behavior on the website, for our website security and for the correct functioning of our website and the related plug-ins or web applications. ASAPCLOUD uses this information to optimize the website's functioning and improve and secure the website as well as possible. ASAPCLOUD may share these data with third parties or third-party applications such as Google Analytics. See the section on 'Sharing with third parties'.

FUNCTIONAL COOKIES

We use functional cookies, which are necessary to ensure our website works properly.

Cookies are files stored on your computer in order to distinguish users or save products in a shopping basket, for instance. These cookies can be deleted at any time via the browser settings on your computer.

TRACKING COOKIES

In addition to functional cookies, we may use tracking cookies as well. These analyses the browsing behavior and investigate advertising preferences. We use external software for this, for instance, a Facebook pixel. Before we use these tracking cookies, we first ask for explicit consent during your visit to our website. You can find this request in the so-called cookie notice bar at the top of the page. You are not required to accept these cookies in order to visit our website. These cookies can also be deleted at any time via the browser settings on your computer.

After this, consent will be requested again. Personal data which are linked to your Facebook or Google account, for instance, can be deleted via the specific organizations.

USE OF SOCIAL MEDIA LINKS

Our pages may contain plug-ins from social networks such as Facebook, LinkedIn and Twitter. If these are used and you have an account with one of these services, these networks may receive data on your browsing behavior. When you visit our pages, these social media plug-ins can establish a direct connection between your browser and the servers of the particular social medium. This informs these parties that you have visited our



website from your IP address. This allows Facebook, for instance, to link your visits to our pages to your user account. We would like to point out that as provider of the pages, we are not notified of the content of the data sent or the use these companies make of the data. If you do not want these companies to link your visit to our pages to your social media account, you must log out of the particular social media channels before visiting our website.

USE OF OTHER PLUG-IN SCRIPTS AND WEB FONTS

Our website uses JavaScript code to ensure correct functioning and display of our website. This can also come from an external party such as Google Webfonts, for instance. If you activate JavaScript in your browser and have not installed a JavaScript blocker, your browser may send personal data if a code is loaded in by one of our suppliers. We do not know what data are linked to the data received and for what purposes these data are used. You can prevent JavaScript code from running by installing a JavaScript blocker (for instance, www.noscript.net).

HOW LONG DOES ASAPCLOUD SAVE DATA?

ASAPCLOUD saves your personal data for no longer than is strictly necessary to realize the purposes for which your data are collected. Your data are not saved for more than 26 months if no contract has been established with you or after any contract with you is dissolved. You can delete cookies at any time via your browser settings.

SHARING WITH THIRD PARTIES

ASAPCLOUD provides your personal data to third parties only if this is necessary for the performance of a contract with you, in order to satisfy a statutory requirement, or to optimize, improve and secure the functioning of our website. This also includes sharing information with web applications, suppliers and hosting providers which are necessary for the functioning of our website and web functionalities. We will handle these data carefully by sending them in anonymized form as much as possible and by concluding a processing agreement with third parties that offer this agreement. Personal data may also be shared with third parties when we use tracking cookies. These will be used only for our own marketing purposes and not shared with/sold to third parties. You can find more information above on how we may use these and how you give consent for this.
